Gentlemen:

This refers to the inspection conducted by Messrs. J. L. Barker, T. M. Tongue, M. J. Jordan, and F. W. Reimann of this office on August 3 to September 6, 1980, of activities at Dresden Nuclear Power Station authorized by NRC Operating Licenses No. DPR-2, No. DPR-19, and No. DPR-25 and to the discussion of our findings with Mr. D. J. Scott and others of your staff at the conclusion of the inspection.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.

During this inspection, certain of your activities appeared to be in non-compliance with NRC requirements, as described in the enclosed Appendix A.

Additionally, during this inspection our inspector observed two licensed operators on duty in the control room who appeared to be asleep. The circumstances associated with this matter are discussed in paragraph 2 of the enclosed inspection report. This event was subsequently reviewed by an NRC investigator from our office, and the results of this investigation will be the subject of separate correspondence from our office.

This notice is sent to you pursuant to the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Section 2.201 requires you to submit to this office within twenty days of your receipt of this notice a written statement or explanation in reply, including for each item of noncompliance: (1) corrective action taken and the results achieved; (2) corrective action to be taken to avoid further noncompliance; and (3) the date when full compliance will be achieved.
