W. Minners (RES) will present for CRGR review a proposed amendment to 10 CFR 50.63 on emergency diesel generator reliability. (This topic was discussed previously by CRGR at Meeting No. 210.) J. Richardson (NRR) will present for CRGR review a 10:00 - 12:00 a.m. proposed supplement to Generic Letter 89-10 on motoroperated valves. [NOTE: The sponsoring office will provide the review package for this item directly to CRGR members by COB, January 12. If the package is received late by the members, this item may be rescheduled for review at a later CRGR meeting.]

If a CRGR member cannot attend the meeting, it is his responsibility to assure that an alternate, who is approved by the CRGR Chairman, attends the meeting.
