Oestmann of this office on May 4-6, 1977, of activities at the Dresden Nuclear Generating Station, Units 1, 2 and 3, authorized by NRC Operating Licenses No. DPR-2, No. DPR-19, and No. DFP-25 and to the discussion of our findings with Mr. B. B. Stephenson and others of your staff at the conclusion of the inspection.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.

No items of noncompliance with NRC requirements were identified during the course of this inspection.
