Reference 1: GLE-2019-0120 submitted on September 19, 2019

GE-Hitachi Global Laser Enrichment, LLC (GLE), received comments from the DOE on our submission in Reference 1. The submission was for revisions to the following documents: GLEP-00023-R Revision 8.5, figures 1 and 3 of 5, which contain updated Classified Distributive Information Network (CDIN) drawings, and GLEP-00015-R Revision 8 Program Cyber Security Plan. DOE provided comments on the GLEP-00015-R revision.

DOE recommended three changes: two to the PCSP and several additions to the Monitoring Report, GLEP-00053-R. GLE agrees with those changes and have expedited the revisions. GLE is resubmitting the revision under the same revision number, Revision 8 for the PCSP due to the previous submission not being approved.

GLE is also submitting a new revision to GLEP-00053-R, Revision 4, PCSP Annual Continuous Monitoring Report. An annual review was conducted and additions were made based on DOE comments. The Continuous Monitoring Report does not contain new test results for the new device, since it is not operational. When the device becomes operational, GLE will perform the controls test and revise the Continuous Monitoring Report.

The GLEP-00053-R, Revision 4 and GLEP-00015, Revision 8 contain Security-Related Information and should be withheld from public disclosure per 10CFR2.390.

These revisions reflect the ongoing restructure of GLE and will provide for secure communication. NRC and DOE approval is requested for all three documents.
