
Dear Mr. Denton:

Duke Power Company is filing herewith Amendment No. 65 to its Application for Licenses for the McGuire Nuclear Station which is under construction pursuant to Construction Permits CPPR-83 and -84. This filing includes three signed original copies of the amendment with attachments entitled, "Revision 40 to the Final Safety Analysis Report" and Revision 3 to Report No. MDS/PDG-77-1, "Evaluation of the Effects of Postulated Pipe Failures Outside Containment for McGuire Nuclear Station". 
