This refers to the inspection conducted by T. D. Gibbons of this office on December 4-7, 1979 of activities authorized by NRC Construction Permit Nos. CPPR-72 and CPPR-73 for the Sequoyah Nuclear Plant facility, and to the discussion of our findings held with J. E. Wilkins at the conclusion of the inspection.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.
