SUBJECT: MEETING SUMMARY - LESSONS LEARNED

The licensee met with the staff on March 7, 1980 to discuss the implementation plan requirements for Lessons Learned and specifically to request approval of the site location for the long term technical support center. The list of attendees is attached as Enclosure 1.

All of the areas of the short term lessons learned were discussed with the licensee with particular attention to those areas where recent clarifications of positions have occurred and where other licensees misinterpreted our positions. Beaver Valley is scheduled to restart in July 1980 and their Lessons Learned implementation plan is due to be reviewed prior to that time. The licensee is beginning to purchase some of the equipment required and those corresponding lessons learned areas will be better defined in the coming months. The lessons learned task force is not expected to review the Beaver Valley plan any time soon because of priority considerations being given to the operating plants.

The licensee had requested the meeting to discuss the location of the long term technical support center. Due to the crowded site at Beaver Valley, the licensee has chosen an area just east of the Unit 2 construction but on the other side of the Shippingport-Midland highway. The licensee has a tunnel access beneath the road. The proposed one story building will be located 1100-1200 feet from the control room. It will house the technical support center, emergency response center, and near site operations center, as well as other offices and rooms to support an emergency situation. The building will normally be used as an office building and training center. Direct communication with the control room will be established with 8 or more closed circuit TV cameras that can scan, tilt, and zoom to all portions of the control boards. Senior licensee management will be located in both the technical support center and control room for effective management of operations. There may also be some consideration to installing picture-telephones between the two points. Details of the proposed building with a site plot and building plan are attached as Enclosure 2.

The staff was unable to respond to the licensee on the location of the technical support center. Discussion are to be held by NRC management on the Arkansas Nuclear Power Plant location of their technical support center and the results of that discussion may help with the Beaver Valley decision. The licensee
