
Dear Mr. Muntzing:

We are Hearing Counsel to The Dow Chemical Company
("Dow") in the above-entitled matter.

Dow has not yet received formal notice that a
Hearing has been requested in connection with the Order
to Show Cause signed by you on December 3, 1973. However,
the press in Midland, Michigan has reported that such an
application was made by the Saginaw group of Intervenor.

Although I assume that Dow will have the right to
continued status as an Intervenor in this further aspect of
the proceeding, as it has in the past, out of an abundance
of caution this will request that Dow continue to have such
right. The grounds are of course identical to those set
forth in Dow's initial Petition to Intervene and in its
application to the Court of Appeals for the District of
Columbia Circuit for the same relief.
