

NRC STAFF'S RESPONSE TO NIPSCO'S MOTION FOR ESTABLISHMENT OF SCHEDULE

I. INTRODUCTION

On June 1, 1981, Northern Indiana Public Service Company ("NIPSCO") filed a "Motion for Establishment of Schedule" in this construction permit extension proceeding. The schedule proposed by NIPSCO calls for (1) completion of discovery (all responses filed and depositions taken) by July 31, 1981, (2) filing of testimony by August 31, 1981, and (3) commencement of hearing on September 15, 1981. The NRC Staff supports NIPSCO's motion for the reasons stated below.

II. DISCUSSION

As noted by NIPSCO, 1/contentions in this proceeding (with an exception discussed be bw) have been admitted for some ten months and discovery has been in process during that period. As to the admitted contentions, therefore, a discovery completion date of July 31, 1981,

seems completely reasonable. $\frac{2}{}$ The Staff now anticipates issuance of its Safety Evaluation Report ("SER") in sufficient time to allow a reasonable opportunity for such discovery as may be spawned by that document. The Staff also anticipates issuance of its environmental impact assessment ("EIA") concurrently with or shortly after issuance of the SER. Thereafter, the Board could rule upon the admission of those proposed contentions of PCCI and the State of Illinois asserting that the Staff is required to prepare an Environmental Impact Statement ("EIS"), which were deferred pending issuance of the EIA. $\frac{3}{}$ Since these proposed contentions $\frac{4}{}$ raise mainly legal issues susceptible of

We note that the Porter County Chapter Intervenors ("PCCI") have noticed depositions of Staff and NIPSCO employees for various dates during August 1981. Before the depositions of the Staff witnesses may, however, be taken, the Board must rule in PCCI's favor on its "...Second Application Pursuant to 10 C.F.R. § 2.720(h)(2)(i)" (June 9, 1981). The Staff's time to respond to PCCI's Application runs through June 29, 1981. We believe that the period between now and July 31, 1981 provides sufficient time for the taking of Mr. Dunn's deposition and of the depositions of the named Staff witnesses, should the Board direct that such be taken.

determination on briefs, there is no present reason to believe their resolution could not be accomplished within the schedule proposed by NIPSCO.

Based upon a discovery completion date of July 31, 1981, we also find the proposed testimony filing date of August 31, 1981, and the proposed hearing commencement date of September 15, 1981, to be reasonable.

III. CONCLUSION

For the reasons stated above, the NRC Staff supports the schedule proposed by NIPSCO.
