This refers to the inspection conducted by Messrs. W. D. Johnson and S. D. Bitter during the period September 6 through October 3, 1989, of activities authorized by NRC Construction Permits CPPR-126 and CPPR-127 for the Comanche Peak Steam Electric Station, Units 1 and 2, and to the discussion of our findings with you and other members of your staff at the conclusion of the inspection.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observation by the inspectors.

During this inspection period, there were two instances noted where certain of your activities appeared to be in violation of NRC regulations. For the violation described in Paragraph 2 of the enclosed inspection report, no Notice of Violation (NOV) is being issued. This action is in accordance with Section V.G.1 of the NRC's Enforcement Policy (10 CFR Part 2, Appendix C). For the violation described in Paragraph 12 of the enclosed inspection report, an NOV is being issued. A written response to this violation is required.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter, the enclosed inspection report, and your response will be placed in the NRC Public Document Room.
