MINUTES OF THE WASTE MANAGEMENT SUBCOMMITTEE AND FUEL CYCLE SUBCOMMITTEE JOINT MEETING JUNE 26 & 27, 1980 WASHINGTON, DC

The Subcommittees met jointly on June 26 & 27, 1980 at 1717 H St., NW Washington, DC. The main purposes of the meeting were to review pertinent portions of the proposed 1982 safety research budget. Notice of the meeting was published in the Federal Register on June 11, 1980. Copies of the notice, meeting attendees list, and meeting schedule are included as Attachments 1, 2, and 3, respectively. No written statement and no request for time to make oral comments were received from members of the public.

EXECUTIVE SESSION

Mr. S. Lawroski, Subcommittee chairman, convened the meeting at 1:00 p.m. and introduced the ACRS members (Attachment 2) who were present. The meeting was conducted in accordance with the Federal Advisory Committee Act and the Government in the Sunshine Act. Mr. Peter Tam was the Designated Federal Employee. Members made no additional comments at this point and the meeting proceeded as scheduled.

DISCUSSION WITH THE NRC STAFF

The following is a record of significant points raised by the Subcommittees and the Staff during a project-by-project review. If a FIN number is given, the point(s) refers to the particular project as listed in the Description of Research Projects (a document provided by the Research staff).

I. High-Level Waste

- The Staff said that the NRC waste management research is very general, and results can usually be applied to all waste forms and sites.
- (B6352) The Staff said that DOE would not be interested in developing techniques to measure leach rates. NRC, on the other hand, would be interested in evaluating various techniques since one of the performance criteria required by 10 CFR 60 is low leach rates.

- The NRC research projects do not involve mining of underground cavities, due to the high cost of such operations; existing sites or mines are being used instead.
- Geologists working in waste management have to be trained to think differently from what other geologists do: the former have to think in terms of avoidance of minerals and underground water, whereas the latter searches for such.
- The regulatory staff (NMSS) supports strong increase of research personnel.
- The staff assured the Subcommittees that there is a strong linkage between research and regulatory development.
- The research staff said that the Commission may be forced to cut LLW research due to an overall research budget cut. The regulatory staff said that it opposes any cut in LLW and U-tailings research.
- The Subcommittee suggested that the Staff should obtain the advice of outside advisory groups on its research projects.
- (B6627, B6664, and B7401) In mining, one does not worry a lot about damaging surrounding rocks; the purpose is just to get useful minerals out. But in excavation for waste storage, one has to exercise great care not to cause damage. These projects illustrate such emphasis.
- (B7404, B7063, B7401, and B6673) The regulatory staff suggests budgets for these should be reduced.
- II. Low-Level Waste (LLW)
 - (B7065) TMI-2 EPICOR waste is treated as LLW, according to NMSS.
 When properly solidified, it can be shipped to Hanford for storage.

WASTE MANAGEMENT/FUEL CYCLE - 3 - 6/26827/80

- Mr. Moeller suggested that the Staff advocate preferred ways for LLW solidification.
- Some nuclear plants generate more waste than others. Proper administrative procedures would enable drastic cuts in LLW volumes. The Subcommittee recommended that the Staff poll all nuclear plants to find out what volume of LLW generated per MWt. Plants that generate too much LLW should be told to improve.

III. U-Mill Tailings

- Mining companies, whose prime objective is to obtain the uranium from the ore, have traditionally lacked motivation to properly treat mill tailings.
- (B7414 and B7420) Every country, except the US, require tailings neutralization as a major step in treatment.
- The regulatory staff said that logic would dictate that mill tailings should get the most attention, but public fear has required HLW research to get the highest priority.

IV. Fuel Cycle

- (B7043) The Subcommittees questioned how the Staff proposes to "develop" decontamination alternatives for nuclear plants with such small amount as \$0.2M. No explanation was offered by the Staff.
- The Subcommittees noted that the Staff has made large improvement in the goals, objective, and management of waste management and fuel cycle research.
- The Staff has written a letter (copy provided) to all medical and academic licensees advising them of the use of temporary storage and subsequent disposa: as non-radwaste as an acceptable means for waste treatment.

The meeting was adjourned at 1:30 p.m. on June 27, 1980.
