Dear Mr. Cavanaugh:

On May 29, 1980, the Commission published a proposed rule, a new paragraph 50.48 and Appendix R to 10 CFR Part 50, concerning fire protection, which sets for the minimum acceptable fire protection requirements necessary to resolve contested areas of concern for nuclear power plants operating prior to January 1, 1979.

We is we reviewed all the information you have provided to date segarding your fire protection program. The status of all currently identified unacceptable items is presented in the Enclosure 1 Table.

Enclosure 2 is our Safety Evaluation of those items we now find acceptable. Enclosure 3 presents our requirements on modifications that would have to be made at your facility to resolve these open items in a manner that would meet the requirements of the proposed Appendix R.
