which you are not releasing.

The amended Act permits you to reduce or waive any copying or location fees if that "is in the public interest because furnishing the information can be considered as primarily benefiting the public." I believe this request to be in the public interest and therefore ask that you waive any fees. Should you decide to assess any fees, I request the opportunity to submit additional information to substantiate a fee waiver.
