I refer to the letter from your office dated March 31, 1980, requesting Executive Branch views as to whether issuance of an export license in accordance with the application hereinafter described would be inimical to the common defense and security of the United States and whether the proposed export meets the applicable criteria of the Atomic Energy Act as amended by the Nuclear Non-Proliferation Act of 1978:

NRC No. XCOM0385 — Application by Teledyne Wah Chang Albany for authorization to export to Argentina a total of 237,000 pounds of zircaloy tubes, valued at \$4,835,000. 166,320 pounds is intended for use in the FRG-supplied Atucha I nuclear power plant and 71,280 pounds is intended for the Canadian-supplied Embalse nuclear power plant. Fabrication will take place in Argentina.

It is the judgment of the Executive Branch that the export contemplated will not be inimical to the common defense and security of the United States, and that this export is consistent with the provisions of the Atomic Energy Act of 1954, as amended by the Nuclear Non-Proliferation Act of 1978, provided that the license is limited at this time to authorize only the export of 166,320 pounds of zircaloy tubing for the Atucha I reactor.

The United States has received assurances from the Government of Argentina by notes (copies enclosed) dated November 18, 1980 and January 6, 1981, addressed to U.S. Embassy, Buenos Aires, confirming that the proposed export will be exclusively used for Atucha I and Embalse nuclear plants and will not be retransferred outside its jurisdiction without the prior consent of the United States Government.

The Atucha I facility is under IAEA safeguards and is covered by Argentine Government assurances to the supplier country, i.e., the FRG, including a pledge of no nuclear explosive use. The zircaloy tubing for Atucha I will be fabricated into fuel assemblies in the Ezeiza fabrication plant under IAEA safeguards.

Therefore, it is the view of the Executive Branch that the requirements of Section 109 of the Nuclear Non-Proliferation Act have been met with respect to this export to Argentina for the Atucha I facility. We are continuing to review the issues relating to the export for the Embalse facility and will advise you when that review is completed.

On the basis of the foregoing, the Executive Branch recommends that the license be issued subject to the proviso stipulated above.

In this connection the Ministry informs the Embassy that the Government of the Argentine Republic agrees to the request made and gives its assurances that the tubes to be supplied by the Teledyne Wah Chang Albany Company will be used in the nuclear reactors of the Atucha I and Embalse power plants and will not be transferred outside the jurisdiction of the Republic without the prior consent of the United States Government. This agreement applies to the XCOMO 385 export application submitted by Teledyne Wah Chang Albany Company with regard to the supply of zircaloy tubes for the Atucha I and Embalse nuclear plants.


