Generic Letter 87-09 Technical Specifications

The wording proposed in your November 21, 1989 submittal for Technical Specification (TS) 4.0.3 was not consistent with the wording provided by the NRC staff in Generic Letter (GL) 87-09. Rather, your proposed TS 4.0.3 generally encompassed the standardized TS 4.0.3 but also included an additional caveat stating that, "surveillance requirements do not have to be performed on inoperable equipment."

This portion of the proposed change to TS 4.0.3 was not discussed in your safety analysis or significant hazards determination that accompanied the amendment request.

If you wish to include this additional caveat in your proposed TS 4.0.3, please provide a supplement to your safety analysis and significant hazards determination to support the change.
