SUBJECT: NOTICE OF EXPIRATION

Your NRC license specified above will expire on the date shown. If you wish to continue your program, you must submit an application for license renewal in accordance with the enclosed instructions.

If your application for license renewal is filed at least 30 days before the expiration date of your license and the application is accompanied by the appropriate fee for license renewal (see 10 CFR 170.31), your license will remain in effect until final action is taken on your application. However, if your application is filed less than 30 days before the expiration date and it cannot be processed before that date, you would be without a valid license when the license expires.

If you do not wish to renew your license, you must dispose of or transfer all licensed radioactive material in your possession in an authorized manner (see 10 CFR 30.36), complete the enclosed Form NRC-314, "Certificate of Dispostion of Materials," and return it before the expiration date of your license with a request that your license be terminated. If you cannot dispose of or transfer all licensed radioactive material in your possession before the expiration date, you must request a license renewal for storage only of the radioactive material to avoid violations of possessing licensable material without a valid license.

This notice of your license expiration is sent for your convenience and it should not be interpreted that similar notices will be sent in the future. The responsibility for timely submission of license renewal remains with the licensee.
