Please find enclosed Amendment No. 40 to NRC License No. 50-18244-01 adding an additional use authorization to Dirk C. Bringhurst, M.D. and adding authorized user Jason Savikko, D.O., as requested. An environmental assessment for this licensing action is not required since this action is categorically excluded under 10 CFR 51.22(c)(10)(v) and 51.22(c)(14)(iv).
