By letter dated September 3, 2018, NRC staff documented requested for additional information (RAIs) that are required to complete their detailed technical review of HI-STORM FW CoC 1032 Amendment Request 5 submitted June 15, 2018. Holtec submitted the requested additional information in two batches. Following each submittal, clarification discussions were held between the NRC and Holtec. Holtec submitted additional information in response to these clarification calls.
