1. Supplement to NUREG-0534, Draft Environmental Statement, and associated Federal Register notice were issued.
2. Fuel Load Forecast Panel held a two-day meeting with the applicant. The applicant forecasts a late-April fuel load date. The Fuel Load Forecast Panel concluded that the plant would not be ready to load fuel prior to August 1980. We also noted that our estimate of the nominal fuel load date was October 1980.

1. Site visit on November 12-14, 1980 by members of the Reactor Systems, Power Systems, and Instrumentation and Control Systems branches.
