Pursuant to the Freedom of Information Act as amended, 5 U.S.C. § 552, and the Privacy Act, 5 U.S.C. § 552(a), I hereby request from you all memoranda, letters, or other records relating to or mentioning the Armadillo Coalition of Texas (sometimes referred to as the Armadillo Coalition or the ACT), and to its local chapters, the Armadillo Coalition of Texas/Dallas (sometimes referred to as ACT/Dallas), and the Armadillo Coalition of Texas/Fort Worth (sometimes referred to as ACT/Fort Worth).

A copy of a notarized affidavit authorizing the Center for Law in the Public Interest to make this request on behalf of the Armadillo Coalition of Texas is enclosed. If you determine that any portion of the records included within this request are exempt from disclosure, I would appreciate your advising me as to which exemption(s) you believe covers the material which you are not releasing.

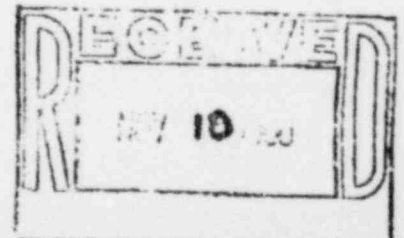
