Gentlemen:

This refers to the special inspection conducted by E. R. Schweibinz of this office on November 5-7 and 21, 1980, of activities at Marble Hill Nuclear Generating Station, Unit 1 and 2, authorized by NRC Construction Permits No. CPPR-170 and No. CPPR-171, the management meeting conducted at the site with yourself, Mr. Petro and Mr. Ramsett, and to the discussion of our findings with Messrs. Petro, Ramsett and others of your staff at the conclusion or the inspection.

The encload copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.

During this inspection, certain of your activities appeared to be in non-compliance with NRC requirements, as described in the enclosed Appendix A. The inspection showed that action had been taken to correct the identified noncompliance and to prevent recurrence. Consequently, no reply to this noncompliance is required and we have no further questions regarding this matter at this time.

In accordance with Section 2.790 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosures will be placed in the NRC's Public Document Room, except as follows. If these enclosures contain information that you or your contractors believe to be proprietary, you must apply in writing to this office, within twenty-five days of the date of this letter, to withhold such infor-

mation from public disclosure. The application must include a -11 statement of the reasons for which the information is considered proprietary, and should be prepared so that proprietary information identified in the application is contained in an enclosure to the application.

We will gladly discuss any questions you have concerning this inspection.
