Subject: Westinghouse Water Reactor Divisions Reorganization

This is to notify you of an organizational restructuring within Water Reactor Divisions effective February 1, 1981. Changes within the Nuclear Equipment Divisions are described below and in the attachments.

To address the continuing shift in the business mix of the Nuclear Equipment Divisions (NED), the NED engineering groups are realigned as follows: The Manager, Nuclear Component Divisions Engineering shall report to the General Manager, Nuclear Component Divisions and shall direct heat exchanger, internals, and commercial product engineering groups and drafting groups. The Manager, Commercial Nuclear Pump Engineering shall report to the General Manager, Electro-Mechanical Division. Continuing to report to the General Manager, NED are the General Manager, Nuclear Component Divisions, the General Manager, Electro-Mechanical Division, and the Manager, Nuclear Equipment Divisions Engineering. In addition the Manager, Nuclear Equipment Divisions Engineering shall continue to be responsible for engineering policy development, new reactor model component development, engineering automation, IEEE and other equipment qualification, and purchase resale equipment engineering. Additionally, he shall maintain a dotted line relationship with the Division engineering groups for these and other engineering matters. The attached chart illustrates these reporting relationships.

Appropriate instructions have been issued to ensure that the controls, described in WCAP-8370 and contained in present internal documents, remain in place. Management is continuing its review of the methods of control to determine if any changes are needed as a result of the restructuring of the organization. Necessary approvals and instructions to implement will be given as required.
