I therefore request that, if you determine that some portions of the requested Records are exempt, you provide me immediately with a copy of the remainder of the Record. I, of course, reserve my right to appeal any such decision.

If you determine that some or all of the Records are exempt from release, I would like to be advised as to which exemptions you believe cover the material which you are not releasing.
