
2. The Plan which is sought to be withheld from public disclosure contains details of the physical security plan for Peach Bottom Atomic Power Station.

The Plan should be considered by the Nuclear Regulatory Commission as confidential and proprietary information and be withheld from public disclosure on the grounds that it contains details of the physical security plans and procedures of a licensed facility, such disclosure is not required in the public interest, and such disclosure would adversely affect the interest of Philadelphia Electric Company.
