We understand that the radioactive material, the authorized users, and the associated locations of use as authorized on NRC License No. 10-06493-02 (Amendment No. 69) will be transferred and used under NRC License No. 45-35423-01 for the Defense Health Agency. Based on the information provided, NRC License No. 10-06493-02 is hereby terminated.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).




