With regard to categories one and two of your request, an NRC staff office provided the enclosed Section 7 from Amendment 22 to the Fort St. Vrain License.

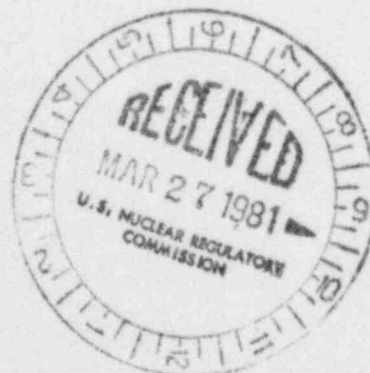
