Dear Dr. Ice:

This is in partial response to your letter of March 6, 1981 in which you requested, pursuant to the Freedom of Information Act, two categories of documents pertaining to inspection reports and preliminary notification reports (PNOs) for nuclear pharmacies under license category 02500.

Please find enclosed the documents listed on Appendix A, which represent the PNOs pertaining to nuclear pharmacies during 1979 and 1980.

With regard to the inspection reports, we have been advised that there are 57 licensees under the 02500 category, some of whom hold multiple licenses. If you do not want to have specific reports and want instead to have access to all inspection reports, there may be additional search time involved. Our best estimate is that it would require approximately one week to complete the search and reproduce the records.
