The Department of Justice (DOJ) shall continue to provide access to the JURIS General Legal Data Base during FY 1981 in accordance with the Memorandum of Understanding for JURIS Online Retrieval Services for Fiscal Year 1980, undated, which is attached hereto and incorporated herein by this reference."

B. Article III - Obligation of Funds is revised to read as follows:

"Article III - Obligation of Funds - The total amount presently obligated for performance of the services required hereunder is \$222,850.00."

Except as provided herein, all terms and conditions of the document referenced in block 8, as heretofore changed, remain unchanged and in full force and effect.
