Dear Mr. Kinneman:

In response to a telecon with NRC employee Joy McGinness, this is to provide official notification of the loss by HRB-Singer, Inc. of a Pm 147 Isotope, S/N C-4158. The Isotope was originally supplied by Twin City Testing, Inc., Tonawanda, New York for use in a Beta Backscatter Plating Measurement Device and has a strength of less than 400 μ C.

The Isotope in question was discovered to be lost on or shortly before 20 January, 1981 by Jack McGinness, Quality Assurance Technician in Room 925A. A thorough search of the area was conducted using a gieger counter as an aid to visual inspection but the Isotope was not found. The nature of the operation requires Isotopes to be placed in a probe and changed for changes in metal type and metal thickness. It is theorized that the Isotope was not put in its proper container after removal from the probe, rolled off the work bench to the floor, swept up, and discarded with the trash.

As corrective action the employees in the area utilizing this equipment have been instructed to place Isotopes in their proper container immediately after removal from the probe.

Initial notification of the loss was to Mr. Serge Joffe of Twin City Testing who advised HRB-Singer that he would notify authorities. Attached is a copy of his correspondence with the State of New York Department of Labor, Division of Safety and Health.
