RESOLUTION

RESOLUTION OF THE TOWNSHIP OF LACEY, COUNTY OF OCEAN, STATE
OF NEW JERSEY, SUPPORTING THE RE-OPENING OF TMI UNIT NO. 1

WHEREAS, after the nuclear incident at Three Mile Island, TMI unit No. 1 was shut down by the NRC even though there was never any problem with the operation of TMI No. 1; and

WHEREAS, the continued shut down of this nuclear reactor places an undue burden on the residents of Lacey Township, as well as all other customers of Jersey Central Power & Light; and

WHEREAS, the loss of the use of this reactor has caused Jersey Central Power & Light to lose sufficient funds to force them to not only discontinue the construction of the additional power plant at Forked River, but also to seek continual rate increases from the Public Utilities Commission; and

WHEREAS, there is no justifiable reason for continuing to keep TMI No. 1 shut down due to the fact that it had an unblemished safety record prior to the record at TMI No. 2.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Committee of the Township of Lacey, County of Ocean, State of New Jersey, as follows:

1. That the federal government should take immediate steps, through the NRC, to permit the re-opening of TMI unit No. 1.
2. That the savings realized by Jersey Central Power & Light by the re-opening of the reactor at TMI No. 1 should be utilized to complete the construction of the second power plant located at Forked River.

RESOLUTION

RESOLUTION OF THE TOWNSHIP OF LACEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, URGING THE FEDERAL AND STATE GOVERNMENTS TO SUPPORT CONTINUED RESEARCH INTO THE DEVELOPMENT OF COMMERCIALY FEASIBLE NUCLEAR FUSION REACTORS

WHEREAS, this country is currently in the midst of an energy crisis;

and

WHEREAS, the development of commercially feasible nuclear fusion reactors would result in ending that energy crisis and ending this country's reliance on the importation of foreign oil; and

WHEREAS, nuclear fusion reactors do not generate significant radioactive waste and have potential to produce far more energy than they utilize to produce said energy; and

WHEREAS, there is currently an operating fusion reactor in Princeton, New Jersey; and

WHEREAS, there exists a need for further research to improve the efficiency and commercial feasibility of nuclear fusion reactors.


NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township committee of the Township of Lacey, County of Ocean, State of New Jersey, as follows:

1. That the federal and state governments should encourage further research and development in the field of nuclear fusion reactors.
2. That the federal government should continue federal funding for research to the field of nuclear fusion so as to encourage the development of commercially feasible nuclear fusion reactors.
3. That there should be a meeting organized by the Ocean County Energy Council to include all Ocean County municipal, county and state representatives for the purpose of allowing the Fusion Energy Foundation to present a formal presentation concerning the advantages and feasibility of nuclear fusion reactors.
4. That a certifies copy of this resolution be forwarded to the Ocean County Board of Chosen Freeholders, the Ocean County Energy Council, the NRC, Congressman William J. Hughes, Senator William Bradley, Senator Harrison A. William, Jr., and President Ronald Reagan, Secretary of Energy Edwin Edwards, Secretary of the Interior, James Watt.
