Meeting Summary:

Meeting on March 11, 1981 (Report No. 50-293/81-09)

Scope: Special, announced management meeting to discuss the results of the NRC board convened to evaluate the licensee's performance from January 1, 1980 to December 31, 1980 as part of NRC's Systematic Assessment of Licensee Performance (SALP) program. Areas addressed included Plant Operations; Refueling Operations; Maintenance; Surveillance; Licensed Operator Training; QA/QC; Reporting; Committee Activities; Procurement; Fire Protection; ISI/IST; Design Changes and Modifications; Radiation Protection; Environmental Protection; Emergency Preparedness; Radioactive Waste Management; Transportation; Security and Safeguards; and Management Controls.

Results: A summary of the licensee performance evaluation was presented. Areas of concern were discussed with corporate and site management. No new enforcement actions were identified. A number of areas where improvements are indicated were identified.
