0 2 Unit 1 in Mode 1 at 100% RTP. At 1400 (CDT), Waste Gas Decay Tank "E" was found to
 0 3 have an oxygen concentration of 2.025% and hydrogen concentration of 14.47%. This
 0 4 required entry into LCO 3.11.2.5.a. There was no effect upon public health or
 0 5 safety. Previous occurrences - none.

CAUSE DESCRIPTION AND CORRECTIVE ACTIONS (27)

1 0 Apparently oxygen was drawn from Unit 2 Tanks during preop testing. The "E" Waste
 1 1 Gas Decay Tank was mixed with other Waste Gas Decay Tanks and the Unit 2 Tanks were
 1 2 isolated to prevent admission of oxygen from them. At 1800 (CDT), the "E" Waste Gas
 1 3 Decay Tank was placed on cover gas to the hold-up tanks and resampled at 2200 (CDT).
 1 4 The oxygen concentration was within limits at 1.4%.
