Whereas the provisional labor overhead rate stipulated in the contract of 95% has been audited and approved as a final overhead rate of 105.9% for FY 1979 and 102% for FY 80; and,

Whereas such overhead rate adjustment resulted in a cost overrun to the contract in the amount of \$3,758.91; and,

Whereas the purpose of this modification is to recognize such overhead rate adjustments and modify Subsection J.2, Consideration, to the contract to reflect such overrun amount;

Therefore, the following change is made to SECTION J - SPECIAL PROVISIONS, Subsection J.2 CONSIDERATION, Estimated Cost, Fixed Fee, and Obligation:

- Total Estimated Cost - The estimated cost to the Government for the performance of this contract for the purpose of Clause 4 of the General Provisions entitled, "Limitation of Costs" is \$88,643.91.
- Obligation of Funds - The amount presently obligated by the Government with respect to this contract is \$94,518.91.
- Fixed Fee - No change made.

Except as provided herein, all terms and conditions of the document referenced in block 8, as heretofore changed, remain unchanged and in full force and effect.
