This refers to the special safety inspection conducted by Messrs. E. R. Schweibinz, J. J. Harrison, C. C. Williams and W. S. Little of this office and Mr. H. J. Wong of our IE Headquarters office, on February 9-10, 1981, and by Messrs. F. C. Hawkins and C. C. Williams on May 7, 1981, of activities at Marble Hill Nuclear Generating Station, Units 1 and 2, authorized by NRC onstruction Permits No. CPPR-170 and No. CPPR-171 and to the discussion of our findings with you and others of your staff at the conclusion of the inspection.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.

No items of noncompliance with NRC requirements were identified during the course of this inspection.

In accordance with Section 2.790 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC's Public Document Room, except as follows.
