Dear Dr. Johnsrud:

On November 12, 1981, I received a copy of the Appeal Board's Order (dated November 10, 1981) which was issued in the above-captioned matters. That Order grants you a 30 day extension of time within which to make the preliminary showing called for by the Appeal Boards in ALAB-654, 14 NRC (September 11, 1981). Since the NRC Staff had not received a copy of the "Request of Intervenor for Extension of Time to Respond to ALAB-654" (request) (filed by you on November 6, 1981), I arranged on November 12, 1981 to receive a copy of the filing in question directly from the Secretary to the Appeal Boards.
