This refers to the routine safety inspection conducted by Dr. J. C. Jang of this office on November 13-17, 1989, of activities authorized by NRC License Nos. DPR-53 and DPR-69, and to the discussions of our findings held by Dr. J. Jang with Mr. R. Wenderlich and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection include your gaseous and liquid effluent control programs as described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed. However, one unresolved item was identified regarding retrieval of the calibration results for gaseous and liquid effluent monitors and is discussed in Section 6.0 of the enclosed inspection report. You are requested to review the identified item and respond within 30 days of the date of this letter on actions planned or taken in regard to this item and their results.


