SUBJECT: COMPLETION OF REVIEW OF THE 1988 BEAVER VALLEY UNIT 1, 10 CFR 50.59 REPORT AND ASSOCIATED SITE AUDIT (TAC NO. 74129)

By letter dated July 20, 1989, the licensee submitted the 1988 Annual Report of Facility Changes, Tests and Experiments in accordance with 10 CFR 50.59. I reviewed that report following the guidance of Section 3.4.4 of Revision 1 of the Project Manager's Handbook.

In addition, I audited the 10 CFR 50.59 analysis documents on site (December 5, 1989) for Design Change Package (DCP) No. 744 and 834, and held discussion with Mr. J. Vassello on DCP 513, 523, 576, 668, 808, and procedures TOP 1-88-28, -29 and -30.

Office review of the report indicates that, where appropriate, licensing actions have been opened to address issues that could not be entirely covered under 10 CFR 50.59. The following licensing actions and issues in the report are related:
