SUBJECT: EXAMINATION REPORT NO. 50-29/89-22 (OL)

On November 28, 1989, through December 1, 1989, the NRC administered examinations to two employees of your company who had applied for licenses to operate your Yankee Nuclear Power Station in Rowe, Massachusetts. Also, three individuals were administered requalification examinations as a result of their having failed various portions of the requalification examination previously administered during the month of June, 1989. At the conclusion of the examination, the results of the requalification examinations and preliminary findings of the replacement examinations were discussed with those members of your staff identified in the enclosed report. Details of the examinations are described in the NRC Region I Examination Report which is enclosed with this letter.
