SUBJECT: NRC INSPECTION OF RANCHO SECO NUCLEAR GENERATING STATION

This refers to the inspection conducted by Mr. J. Russell of this office on October 23 through 27 and November 5 through 9, 1989, of activities authorized by NRC License No. DPR-54 and to the discussion of our findings held by Mr. Russell with Mr. Shetler and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Based on the results of this inspection, it appears that some of your activities were not conducted in full compliance with NRC requirements as set forth in the Notice of Violation, enclosed herewith as Appendix A.
