Dear Mr. Johnson:

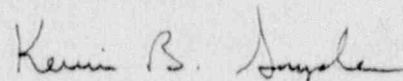

Gentlemen:

This refers to your March 13, 1989 letter for an amendment to Materials License 29-19445-01 to change the authorized place of use.

An amendment fee of \$60 is required as specified in fee Category 3P of §170.31 of the enclosed 10 CFR 170. In addition, Invoice No. 0812B issued to Air Products & Chemicals, Inc., in the amount of \$530, copy enclosed, has not been paid. Second and final notices were sent to the company. The invoice is for an inspection conducted on February 25, 1988, of License 37-05105-05 of the activities at the Allentown, PA site.

Please refer to §170.41 of the enclosed 10 CFR 170 that "In any case where the Commission finds that an applicant or a licensee has failed to pay a prescribed fee required in this part, the Commission will not process any application and may suspend or revoke any license or approval issued to the applicant or licensee or may issue an order with respect to licensed activities as the Commission determines to be appropriate...." Accordingly, your March 13, 1989 amendment request will not be processed until the \$60 amendment fee and the principal and related charges are paid for Invoice No. 0812B. The penalty and interest and administrative charges through June 15, 1989 total \$196.10 accruing at 19¢ per day until paid.

We request you give this matter your immediate attention and remit the \$60 amendment fee and \$726.10 for Invoice No. 0812B within 15 days from the date of this letter in order that we may begin processing your March 13, 1989 application.
