Subject: Enforcement Conference Conducted December 6, 1989

This letter refers to the Enforcement Conference conducted at our office in King of Prussia, Pennsylvania with you, other members of your staff and Mr. Irving Kator, Esq., and me and other members of the NRC staff on December 6, 1989. It is our view that this conference was beneficial in that it allowed us to fully explain our concerns regarding the apparent violations identified during our inspection conducted on June 6, 1988 and March 17, 1989 and the NRC Office of Investigations (OI) conclusion regarding an apparent false record and apparent false statements. In addition, the conference gave us a better understanding of your corrective actions, the circumstances associated with the apparent violations and your admittance or denial of them.

The subjects discussed at this meeting are summarized in the enclosed Enforcement Conference Report. The Enforcement Conference was transcribed by a court recorder and the transcript is attached to the enclosed Conference Report. Enforcement action resulting from the apparent violations discussed at this meeting will be provided to you by separate correspondence.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room.

No reply to this letter is required. Your cooperation in this matter is appreciated.
