The purpose of this modification is to: (1) provide CY 1990 funds thereby increasing the obligated amount, and (2) revise the Statement of Work to change the rate of payment for CY 1990, and (3) change the technical representative's name and telephone number. Accordingly, the cooperative agreement is hereby modified as follows:

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.

1. Under Article V - Consideration and Payment, paragraph A., Consideration, paragraph 3, is deleted in its entirety and the following paragraph is substituted in lieu thereof:

"3. The amount presently obligated by the Commission with respect to this cooperative agreement for CY 1990 effort is \$34,400.00. The total amount obligated since inception of this agreement is increased by \$34,400.00 from \$198,550.00 to \$232,950.00."

2. Under Attachment A., Section II, paragraph B., is deleted in its entirety and the following paragraph is substituted in lieu thereof:

"B. Program will be undertaken at the following sites and the rate of payment will be as follows:

2. Also under Section III, paragraph F., is deleted in its entirety and the following paragraph is substituted in lieu thereof:

"F. The State will notify the NRC Region II Technical Representative, Mr. Thomas Decker, by telephone (404-331-2559 or FTS 481-2559) and written confirmation as soon as practicable after it becomes aware of any observed unusual condition, level of radiation, or concentrations or radioactive material measured in carrying out the programs at individual sites."

All other terms and conditions of this cooperative agreement remain unchanged.
