Gentlemen:

This letter refers to our review of your activities conducted in the state of Oklahoma under reciprocity with Byproduct License No. L02627 issued by the state of Texas. This also acknowledges receipt of NRC Form-241, which you submitted to report proposed activities in non-Agreement States under authority of the general license provided in 10 CFR 150.20.

During this review, certain of your activities were found not to be conducted in full compliance with NRC requirements in that you failed to provide notification to NRC of your activities in Oklahoma performed under the general license. Consequently, you are required to respond to this matter in writing, in accordance with the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Your response should be based on the specifics contained in the Notice of Violation enclosed with this letter.

Our letter to you dated November 24, 1989, confirmed your commitment to cease radiographic operations using byproduct materials at locations under NRC jurisdiction pending further review by our office. We hereby grant permission for you to resume such activities in accordance with your Form-241 submittal dated November 27, 1989. Your Agreement State license is recognized as valid for the uses identified in that submittal.

The response directed by this letter and the accompanying Notice is not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.

Should you have any questions concerning this letter, we will be pleased to discuss them with you.
