


The purpose of this modification is to revise the indirect rates. Accordingly, the contract is hereby modified as follows:

Under Subsection G.1, "Indirect Rates", paragraph "a" is deleted in its entirety and the following new paragraph "a" is substituted in lieu thereof:

"a. Pending the establishment of final indirect rates which shall be negotiated based on audit of actual costs, the Contractor shall be reimbursed for allowable indirect costs as follows:

These rates shall apply to all task orders issued under this contract. Contract ceilings and individual task order ceilings remain unchanged."

All other terms and condition, including the contract ceiling amount of \$3,066,035.00, remain the same.
