 - H. License Condition 10 provides that licensed material may be stored at 615 Piikoi Street, Suite 1001, Honolulu, Hawaii, which is also the licensee's address in Items 1 and 2 of the subject license.
 - I. ~~Contrary to the above requirement, the licensee moved their licensed program to 550 Paiea Street, Suite 232, Honolulu, Hawaii, with a storage area nearby without amending the license to specify the new address and storage area.~~
