As documented in my inspection report dated December 5, 1989, ANC has completed the second phase of their reclamation project. This phase of the project involved the reshaping of the southern half of tailings pond No. 2 and the millsite. Also six inches of interim cover has been placed on the regraded surface.

The most recent bond estimate submitted by ANC was contained in their April 1989 annual report. ANC estimated their costs, including 34.5% contingency and overhead, for the eight phases as follows:

In August 1989, we credited ANC for the completion of the mill demolition phase and thus reduced their bond to \$3,524,340. This is the current bond amount. It should be noted that NRC concurrence was obtained (see Dale Smith's letter of April 10, 1989) for release of the funds for completion of the mill demolition phase.

ANC reestimated the cost of the Phase 2 work in a letter dated August 15, 1989 addressed to Mr. Roger Shaffer. Whereas their April 1989 annual report had a figure of \$446,995. ANC increased this figure to \$470,355 to include the placement of interim cover material in this phase. This reduces the Phase 3 costs by \$22,598 since a portion of the cover has already been placed in Phase 2.
