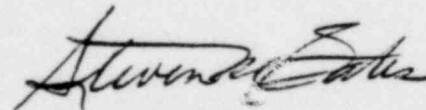
In response to your letter concerning Mr. Sutton's finding, we have taken the following steps for corrective action on the Division Manager Audits 15.2.1 of our Pittsburgh-Des Moines Steel Company, (PDM), Corporate QA Manual: The Division Manager, Mr. Sheldon Biber, has issued a letter outlining the dates for the audits, (see attached). The dates of these audits may vary a few weeks. We have completed one audit at our Braidwood, Illinois site already, and will complete the Byron, Illinois site by the end of January, 1981. The Bay City site will be completed by the end of February, 1981. This schedule will be updated every year by the Division Manager to prevent reoccurrence.

I am confident that the above plan will satisfy the requirements of our QA manual and will correct the deviation pertaining to Division Audits. As far as the Corporate Audit schedule, this information will be forth coming in letter form from Mr. Roger Eastman, the Corporate Coordinator, QA.
