

Dear Sir:

This is a request under the Freedom of Information Act as amended (5 U.S.C. 552).

I write to request copies of all documents relating to the consideration, planning, execution, and utilization of studies undertaken by your agency, or by other parties for your agency and/or other agencies, which pertain, in part or in whole, to public opinion on nuclear (atomic) energy and issues relating to the use of nuclear power as a means of energy production. This would include, but is not necessarily limited to, opinion polls, review or analyses of media coverage, mail received, telephone calls, or other indicators and means of communication which your agency uses or has used to identify, study, measure, and analyze opinions on nuclear energy and related scientific, technical, or social issues. For example, I am interested in reports, memorandum, correspondence, work papers, minutes of meetings, and staff papers <u>based</u> on an analysis of telephone calls. I do <u>not</u>, however, wish to receive logs of the telephone calls themselves. This request pertains to your agency and its predecessor agencies.

The FOIA also provides that if only portions of a file are exempted from release, the remainder must be released. I therefore request that I be provided with all non-exempt portions which are reasonably segregable. I, of course, reserve my right to appeal the withholding or deletion of any information.

As provided in the Freedom of Information Act, I will expect to receive a reply within ten working days.
