

The emergency procedure guidelines contained in the enclosed report, CEN-152, are intended to supersede and replace corresponding guidelines contained in report CEN-128 (Reference D) which was transmitted to you by Reference (E). Principally, the CEN-152 guidelines contain increased technical information and guidance for dealing with unanticipated accidents, including multiple failures, beyond that contained in the CEN-128 guidelines. However, the decision whether to use the CEN-128 or CEN-152 guidelines, or others, remains the prerogative of each individual utility.



The individuals to whom copies should be addressed will be identified with each future Owners Group submittal.

Questions from the NRC on issues beyond the scope of previous submittals made by the C-E Owners Group should be addressed only to the individual licensees. The licensees will then consider the extent of the C-E Owners Group involvement, if any, in an appropriate response.

The C-E Owners Group feels that this communication policy serves the best interests of the Owners Group, individual licensees, and the NRC.
