All other conditions of this license shall remain the same.

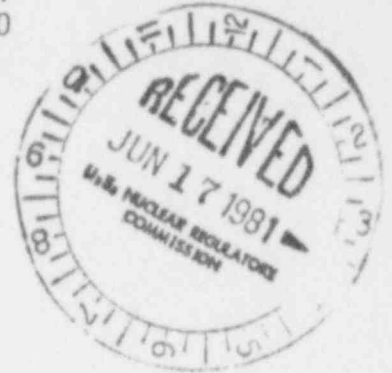
